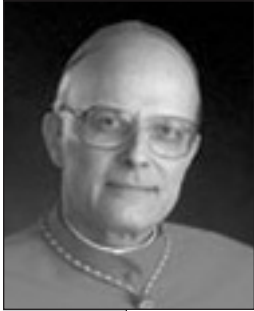

FORTY YEARS AFTER VATICAN COUNCIL II: *THEOLOGY AND CHURCH*

HIS EMINENCE FRANCIS CARDINAL GEORGE, O.M.I., ARCHBISHOP OF CHICAGO



His Eminence Francis Eugene Cardinal George, O.M.I., eighth Archbishop of Chicago, is the first native Chicagoan to serve as Archbishop of Chicago. He entered the Missionary Oblates of Mary Immaculate in 1957 and was ordained a priest in 1963.

Cardinal George earned a master's degree in philosophy at The Catholic University of America in 1965 and a doctorate in American philosophy at Tulane University in 1970. In 1971, he received a master's degree in theology from the University of Ottawa. He obtained a Doctorate of Sacred Theology in ecclesiology from the Pontifical Urban University, Rome, Italy in 1988.

Pope John Paul II appointed him Bishop of Yakima in 1990. He served there for five and a half years before being appointed Archbishop of Portland in Oregon in 1996.

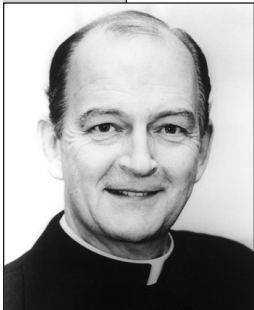
Less than a year later, on April 8, 1997, Pope John Paul II named him the eighth Archbishop of Chicago, to the See left vacant by the death of Joseph Cardinal Bernardin. On January 18, 1998, Pope John Paul II announced Archbishop George's elevation to the Sacred College of Cardinals.

He is Vice President of the U.S. Conference of Catholic Bishops, Chairman of the USCCB Committee on Liturgy, and a member of the USCCB ad hoc Committee on Shrines and the Subcommittee on Campus Ministry.

FORTY YEARS AFTER VATICAN COUNCIL II: *ECUMENISM*

REVEREND RICHARD JOHN NEUHAUS, EDITOR, *FIRST THINGS*



Father Richard John Neuhaus is acclaimed as one of the foremost authorities on the role of religion in the contemporary world and is President of The Institute on Religion and Public Life, a nonpartisan inter-religious research and education institute. He is editor-in-chief of the Institute's publication, First Things: A Monthly Journal of Religion, Culture, and Public Life. Among his best known books are Freedom for Ministry, The Naked Public Square: Religion and Democracy in America, The Catholic Moment: The Paradox of the Church in the Postmodern World, and Believing Today: Jew and Christian in Conversation. In 1995, he edited Evangelicals & Catholics Together: Toward A Common Mission (Word).

As a Lutheran clergyman, he served as senior pastor of a parish in Brooklyn, New York. He has played a leadership

role in organizations dealing with civil rights, international justice, and ecumenism. Father Neuhaus has been the recipient of numerous honors, including the John Paul II Award for Religious Freedom. He held presidential appointments in the Carter, Reagan, and first Bush administrations. In a survey of national leadership, *US News and World Report* named Father Neuhaus one of the "most influential intellectuals in America." Father Neuhaus was named one of the most influential religious leaders in America by *Time Magazine* in 2005.

Born in Canada, Father Neuhaus graduated from Concordia Theological Seminary, St Louis, Missouri. In 1991 he was ordained a priest in the Archdiocese of New York by the late Cardinal John O'Connor.

HELEN ALVARÉ, ASSOCIATE LAW PROFESSOR, THE CATHOLIC UNIVERSITY OF AMERICA



Helen M. Alvaré, who received her juris doctorate from Cornell University in 1984 and a master's degree in theology from The Catholic University of America in 1989. She currently is an associate professor on the law school faculty at The Catholic University of America in Washington, D.C.

In 1987 she joined the National Conference on Catholic Bishops, first in the Office of General Counsel and later as the director of information and planning for the bishops' pro-life

office. Alvaré also spoke for the American Catholic bishops in television, radio, print media and public lectures. Alvaré has testified on behalf of the bishops before federal congressional committees and lobbied members of Congress on federal legislation concerning abortion, health care and welfare reform.

Alvaré previously worked as a staff attorney for the National Conference of Catholic Bishops and as an associate at Stradley, Ronon, Stevens and Young in Philadelphia.

All events will be held at the Archbishop Cousins Catholic Center, located at 3501 S. Lake Dr., St. Francis. Each evening will begin with a prayer service, followed by the lecture, a question and answer session, and a reception.

On April 5 and June 2, exposition of the Eucharist will begin at 6 p.m.

In 2003, Milwaukee Archbishop Timothy M. Dolan introduced the Pallium Lecture Series as an opportunity for members of the Catholic community of southeastern Wisconsin to learn from national and international experts on a variety of topics that are pertinent to Catholic life in today's world.
