## To All Holders of the ODOT Standard Sign Design Manual (SDM):

Transmitted herewith are **two new** standard sign designs, **seventeen revised** designs, **five updated drawings** and **one rescinded** design (see the attached list for details). The related indexes have been updated, including some additional cross-referencing to related federal designs. The new indexes should be placed in the front of each related section of the manual, the new sign designs should be inserted in numerical order in each section, and the revised drawings/designs replace existing ones.

We are in the process of redesigning this manual to be accessible from the Web. You will find that drawings, starting with this revision will be slightly different in style from prior drawings.
