IMPORTANT INFORMATION:

- Example 2 Federal law requires first-time voters who register by mail to show proof of identification in order to vote. You may be able to satisfy this requirement by providing your driver's license number or, if you don't have a driver's license, the last 4 digits of your social security number on this form. If we are able to verify your identity with one of these numbers, it will not be necessary for you to show ID in order to yote. If we cannot verify your identity through a valid driver's license or social security number, you will need to provide identification before you can vote. Acceptable forms of identification include: a copy of a current and valid photo ID, or a copy of a current utility bill, bank statement, government check, paycheck, or other government document that shows your name and address. A copy of your identification can be mailed in an envelope to us along with this registration form, or can be shown the first time you vote.
