OLS Discussion Points And Questions Department of Environmental Protection

Federal Funds

Please explain the disposition of these federal funds, and the reason they are listed in the budget year after year. How are these activities supported without the indicated federal support?

The Legislature, through separate appropriation acts, annually provides these federal funds to the Wastewater Treatment Fund and the Drinking Water State Revolving Fund. As such the expenditures are not reflected in the General Fund; however these anticipated federal funds are included in the annual budget to insure that the estimate is fully reflective of the Department's levels of activities.

Smart Growth

Please describe the establishment and functions of the Division of Smart Growth, including its budget and staffing status at the present time and later, when it becomes fully operational. How will the \$20 million appropriation be distributed amongst the participating agencies and how will subsequent funding allocations be determined?

The \$20 million legislative appropriation/authorization included as part of the Fiscal Year 2005 appropriation act was limited by the Office of Management and Budget to \$4.5 million to begin and fund the upfront costs associated with implementing the Fast Track legislation. As such the current funding level is distributed as follows:

This level of funding is not sufficient to implement, even initially, the Fast Track permitting program at DEP, let alone the other agencies. As for the distribution of the anticipated Fiscal Year 2006 \$20 million authorization, no final allocation decisions have been made. As in FY'06 there is no appropriation of general revenues or an appropriation of anticipated receipts. The number of staff required to run the program and the associated cost will be dependent upon the final program rules and the scope of the program as determined following consultation with the United States Environmental Protection Agency.

To date the DEP has filled 12 positions to implement the Fast Track Growth Act. Four positions have been assigned to the Division of Smart Growth and are engaged in drafting rules in response to the Act and EO140. Five are assigned to the Office of Information Resource Management developing new electronic permitting applications which will be used to expedite the permitting process and GIS interfaces which will allow applicants to identify whether they are in a Smart Growth area. The remaining three are assigned to Management and Budget to assist in hiring, budgeting, accounting and procurement for the Division as it is established.

Implementation of the Fast Track expedited permit process necessarily will be incremented given the resource constraints. The Qualified and Registered Professional Program rule is currently being developed. It is anticipated that 5 staff can adequately operate the Qualified and Registered Professional Program. Adoption of DEP Program specific rules is anticipated in January 2006. Between three and eight rules effecting the Land Use Program, Water Allocation Program, Watershed Management Program and the Treatment Works Program could be ready for adoption. This effort is anticipated to require a significant number of staff. DEP will staff up slowly and in relation to the number of Smart Growth permit application received.

Remaining rule proposals affecting Wetlands, NJPDES and Safe Drinking Water will be initiated according to guidance anticipated from the USEPA this spring.

Local Tire Management

What is the projected status of the program in FY 2006? How was the current appropriation distributed?

Based on the Governor's Proposed Fiscal Year 2006 Budget, the program will not be funded. However, the Department would seek applications in Fiscal Year 2006 from local governments if funding is made available.

Relative to Fiscal Year 2005 the Department received applications from 20 local governments totaling over \$2.9 million dollars. The \$2.3 million appropriation was distributed as follows: \$100,000 was allocated for tire removal at state parks and wildlife management areas, with the balance of the \$2.2 million, awarded to 16 of the applicants, 12 counties and 4 municipalities. The specific listing of grant awards is included as Attachment I.

Stormwater Management Grants

Please provide a listing of the grants awarded thus far. What is the total funding request of pending grant applications? Are any towns in danger of not meeting federal mandates because of insufficient grant funds? Will this program be reinstated at a later date if sufficient CBT monies become available?

The listing of the grants awarded under the Fiscal Year 2004 appropriation is included as Attachment II. As of this date, 93 percent of the Fiscal Year 2004 \$6 million in combined CBT/Federal (\$6 million) funds have been awarded. The process of awarding \$6 million in CBT funds appropriated for Fiscal Year 2005 has been initiated but no grants have thus far been awarded. The list of grant applications pending under the Fiscal Year 2005 appropriation is contained in Attachment III. These grant funds are being awarded to help offset part of the cost of complying with the federal mandates of the Municipal While the costs to comply with the program Stormwater regulation Program. requirements exceed the amount of grant funds available, municipal compliance with the mandates is not linked to the award of these grants. Additionally, the Department is utilizing other funding sources such as the 1985 Wastewater Treatment Bond Act and the New Jersey Infrastructure Financing Program to finance the capital projects aimed at implementing these requirements.

The Department has consulted closely with affected municipalities and with the New Jersey League of Municipalities as we have implemented the Federal mandate. As a result of this consultation, we developed a series of understandings and proper modifications that were memorialized by a letter dated April 11, 2005. We believe this close partnership with the League will ensure successful implementation of the federal mandates, while recognizing the funding challenges facing New Jersey's municipalities.

This letter is provided as Attachment IV.

Highlands Water Protection and Planning Act

Why is the language not continued in FY2006? Please describe the present and planned disposition of the FY 2005 and FY 2006 appropriations, including staffing and operational requirements. Why does the Budget Recommendation indicate \$2.166 million for the FY 2005 appropriation when the actual amount was \$1.558 million?

The appropriation act language that authorized a \$2.1 million appropriation to implement the Highland Water Protection and Planning program was not continued in Fiscal Year 2006 based on the inclusion of a specific line item appropriation to fund the same without the necessity to include authorizing language.

Identified below is the allocation of the Fiscal Year 2005 and Fiscal Year 2006 funding:

The budget's display of the Highland's allocation of \$1.5 million versus the \$2.1 million appropriation reflects the part year nature of implementing this act. In effect the \$2.1 million will fund 39 new positions. To date we have filled 22 and are in the process of recruiting for an additional 4. Thus the \$1.5 million will fund the staff currently assigned to the program.

CBT - Capital Funding

How will the projected decrease in funding affect the hazardous site remediation, underground storage tank, and brownfields programs' project priorities and implementation schedules in FY 2006? Will the receipt of federal or responsible party funding support be affected by the CBT reductions and, if so, how? How much of the CBT dedication for hazardous substance discharge remediation has been allocated to the Brownfield Site Remediation Fund thus far, and for what projects?

Governor Codey's "Time's Up for Cleanup" initiative, announced on Earth Day, supports the Department's efforts to use enforcement tools more aggressively. Our objective is to compel completion of site cleanups that have languished for years and ensure that through more effective use of cleanup directives and other tools, public cleanup funds will be recovered and augmented by treble damages recoveries, where appropriate.

No negative impact is expected. Based on DEP's spending history over the five-years (Fiscal Year 2000-2004) expenditures averaged nearly \$22 million per year and obligations have been established at an average rate near \$25 million per year. Of the amount spent annually, approximately 40% has been expended as the State share for federal projects. However, during this same five year period federal funding has decreased so the state match requirements have correspondingly declined. Based on the average expenditure of \$22 million, the \$29.5 recommended appropriation should to be sufficient for FY2006, provided there are no emergent situations and federal funding for projects remains diminished. The UST remediation fund has a surplus of approximately 100 million dollars that has accumulated over the last few years. The DEP has recommended to the Treasurer that we evaluate the possibility of relaxing the language in the constitutional dedication so that this money can be used for other environmental priorities.

Of the \$17.4 million appropriated in Fiscal Year 2005 for the Brownfield Program, \$6 million has been transferred to the Brownfields Site Reimbursement Fund. Under the Brownfield and Contaminated Site Remediation Act (BCSRA) a developer that enters into a redevelopment agreement may potentially recoup up to 75 percent of their cleanup costs. The NJ Commerce and Economic Growth Commission and the Department of Treasury, in consultation with NJDEP, negotiate and approve redevelopment agreements. Redevelopment agreements currently cover the following projects: Passaic Investors, Cooper's Ferry Development Association, Jayson Family II, LLC, Lafayette Yard Community Development Corporation, American Stores Realty Corp., Great A&P Tea Company Inc and Snowbird Corporation,

Endangered and Non Game Species Program

Notwithstanding recent appropriations to provide state funding to this program, what other options are being considered to provide matching funds for the federal FY 2004 and FY 2005 allocations? If these federal funds cannot be fully matched, how would the endangered and nongame species program be affected?

The Division of Fish and Wildlife's Endangered and Nongame Species Program (ENSP) has historically been funded through donations and foundation grants. Recently, ENSP has benefited from federal grants under the State Wildlife Grant program and we have matched these grants with money from the tax check-off and license plate sales. In FY05, 42 percent of ENSP's budget came from State Wildlife Grants.

If (A3345/S1863) is not passed, Fish & Wildlife could lose over \$1 million in federal State Wildlife Grant program money. This will most directly jeopardize the Endangered and Nongame Species Program (ENSP) operations, because State Wildlife Grants are aimed at preventing wildlife from becoming endangered under federal law. Two other annual sources (State tax check-off and Wildlife license plate) are used to meet part of the federal grant match, but must also be used to fund activities that are ineligible for federal funds.

If Fish & Wildlife does not receive the State Wildlife Grant funding, ENSP staff would have to be laid off, and many research and survey programs for rare wildlife would end. The Landscape Project, which maps lands that are actual and potential wildlife habitat, is one project that would be seriously affected, because it relies on continual updating with wildlife data to remain current. If the Landscape Project mapping is not current, its utility to the DEP's permit programs and local agencies will decline.

Parks Capital Funding

Please provide an estimate of the deferred maintenance costs of the State park and forest system. How long can required maintenance continue to be deferred before such facilities have to be closed or limited to the public due to health and safety Of the \$37.9 million federal fund recommendation for parks management, what monies, if any, could be redirected or used for deferred maintenance projects?

Based on our Capital Improvement Plan Fiscal Year 2006-2008 which was submitted to the Commission on Capital Budgeting and Planning, we estimated that \$212 million would be needed for Renovation and Rehabilitation projects representing the capital costs of deferred maintenance.

The Division of Parks & Forestry administers and maintains over 396,000 acres of open space, nearly 2,000 buildings and structures, approximately 400 roads and over 1,500 miles of trails. Providing a tangible timeframe on the length of time we can continue to defer maintenance on our facilities is nearly impossible given the diversity and range of responsibility. With no capital funding recommended for FY06 any significant damages to a building and/or area could immediately close it due to health and/or life safety factors.

Of the \$37.9 million in identified federal funding very little could be redirected for deferred maintenance. Approximately \$25 million is allocated to land acquisition, one third (\$10 million) is anticipated to be made available under the Intermodel Surface Transportation Efficiency Act (ISTEA) for trial construction and the balance is allocated to the State's Historic Preservation program and Natural Lands Management.

Sale of State Lands

Which DEP-owned properties or assets are being considered for sale as part of the \$500 million revenue enhancement proposal? What criteria were used to identify such properties or assets? What impact would the sale of each property being considered have on the department's operating budget and unmet capital needs, respectively?

The Treasurer's Office recently identified a potential listing of properties that the Department has been asked to review for potential sale. This listing represents all properties owned by the DEP. We have provided information on the impacts on the potential sales to his staff for the purpose of meeting his commitment to you to provide an update before June.

The majority of the Department's land assets were acquired through dedicated funding sources including the various Green Acres Bond Funds dating back to 1961, the Garden State Preservation Trust Fund, the Hunters and Anglers Fund and federal Land & Water Conservation Funds. Pursuant to the statutes establishing these Funds, revenues derived from the sale of any of these assets must be returned to the original funding source. This legislative provision also applies to Green Acres development funds. Specifically, under N.J.S.A. 13:8A-48(a) "Lands acquired or developed by the State...from the State Recreation and Conservation Land Acquisition and Development Fund shall not be disposed of or diverted to use for other than recreation and conservation purposes without the approval of the State House Commission. Such approval shall not be given unless the Commissioner agrees to pay an amount equal to the value of such land, as determined by the Commission, into that fund."

Additionally, under N.J.S.A. 13:1D-52(a), The Ogden-Rooney Act, (triggered by the conveyance of one or more acres) the Department cannot convey or dispose of any lands acquired or developed by the State with Green Acres funds, or acquired or developed by the State in any other manner and administered by the Department of Environmental Protection, or any agency of the department, unless the Department prepares a report that identifies the advantages and disadvantages, and benefits and detriments; assesses the environmental and recreational impact; evaluates impact to endangered and nongame species and assesses the environmental and economic value of the lands proposed to be conveyed under both their current and proposed use. The report must be submitted to the Legislature, and the public in advance of the two required public hearings on the proposed conveyance which are to be held 90 days in advance of the date on which the proposed conveyance is to be heard by the State House Commission. Public hearings for conveyances of more than five acres and \$50,000 in value are required to be held; one in the respective municipality and one in Trenton. For minor conveyances (between one acre and not more than five acres and less than \$50,000 in value) only the municipal public hearing is required.

There is also a review process and preservation requirements related to the sale of the Department-owned historic sites that have National and State Register and Landmark status. Selling, leasing or otherwise de-accessioning a site listed on the NJ Register of Historic Places is reviewable pursuant to the NJ Register of Historic Places Act.

The Green Acres Program maintains a database on all properties acquired or developed with Green Acres and Garden State Preservation Bond Funds. Using the asset list provided by the Department of Treasury, the Department searched its database by the listed block and lot. The database search revealed that the majority of these assets were acquired or developed with dedicated funds. Therefore, based on the statutes cited above, the Department is not recommending the sale of any assets. However we are willing to work with the Treasurer in the case of assets that are not so restricted in terms of sale proceeds including some administrative locations or other assets purchased through means other than those mentioned above.

Dear Bill:

Thank you for your continuing input as we assist municipalities in meeting municipal stormwater requirements mandated by the United States Environmental Protection Agency (USEPA).

As we have discussed, every state is in the process of implementing these requirements, and our consultations with the League persuaded us to delay implementation well past the original USEPA deadline. The Department also has worked with the Legislature to provide \$12 million in support to municipalities in meeting these requirements.

I am grateful for the leadership among municipalities in meeting these requirements. My own town of Lambertville just adopted its stormwater ordinance well ahead of schedule, and other municipalities are showing comparable diligence. I also recognize, however, that some municipalities have faced significant challenges in meeting the first deadlines in the current permits, and that these challenges have been exacerbated by the fiscal budget crisis confronting state and municipal governments.

With these considerations in mind, the Department will continue its compliance assistance focus by exercising its enforcement discretion and will not take any enforcement action prior to August 1, 2005. During this time, the Department will work with the State League to identify any potential changes to the Tier A and Tier B Municipal Stormwater Regulation Permits that would still meet the federal standards while maintaining the State's obligations. This effort will include clarifying any misunderstanding regarding some of the permit conditions such as street sweeping, where municipalities may not understand that the requirement only applies to municipallyowned, curbed streets that have 35 miles per hour or less speed limit, in a predominantly commercial area, and not to the entire municipality.

In addition, as you are aware the Department is already proposing to modify the Tier A and Tier B Permits to address certain critical issues such as the Pinelands Stormwater Management Ordinance, and changing the yard waste requirements to provide more

flexibility to municipalities. Furthermore, the vehicle washing issue will be addressed by modifying the Tier A and B Permit to allow municipalities until February 28, 2009 (the end of the current permit cycle) to implement measures to address vehicle washing. The Department will commit to work with the State League along with the appropriate State and County agencies to explore opportunities to provide regional vehicle washing facilities.

Please be assured that the Department's Municipal Stormwater Program and Enforcement staff will continue to provide compliance assistance and to guide municipalities throughout the process.

I look forward to working with you and with all affected municipalities toward successful implementation of these rules.
