

#### Student Hosts. (Bylaw 13.6.6.5)

Student Hosts must be either current student-athletes or students designated in a manner consistent with Drexel's policy for providing campus visits or tours to prospective students generally, as in from the admissions office. Student-managers or other student employees are not permitted to host prospects unless they are designated hosts by the admissions office. A student-athlete MAY NOT host a prospect unless he or she has signed the Official Visit Signature Form, indicating that he or she has been informed of all regulations pertaining to official visits. In addition, this student must read and sign the Student Host Form before greeting the prospect.

A maximum of \$30 for each day of the visit to cover all actual costs of entertaining the prospect may be provided to the student host. This excludes the cost of meals and admission to campus events. These funds MAY NOT be used for the purchase of souvenirs. It is permissible to provide the student host with \$15 per day for each additional prospect the host entertains. A complimentary meal at a restaurant may be provided to the student host.

#### Other Regulations During a Visit.

Miscellaneous, personalized recruiting aids or game-day simulations MAY NOT occur during a visit. This may include personalized jerseys, scoreboard presentations, locker room and dorm room decorations and the like. (13.6.6.9) Prospects may be allowed in locker rooms prior and/or subsequent to competition.

Drexel Athletics shall maintain adherence to the Code of Conduct in the Drexel University Student Handbook. The following excerpts from the Handbook's Code of Conduct should also be reviewed with potential student hosts.

The Alcohol Policy states that "the consumption, distribution, or service of alcoholic beverages must be in compliance with the Pennsylvania liquor and crime codes...and must also comply with University regulations and policies." Violations of the University alcohol policy include, but are not limited to:

1. Possession, use, or distribution of alcohol by underage persons;
2. Disorderly conduct due all or in part to being under the influence of alcohol;
3. Providing alcohol to underage persons;
4. Possession of an open alcohol container in a public area regardless of the individual's age;
5. Possession or use of bulk containers including, but not limited to, kegs, beer balls, or any other object that would promote binge drinking is not permitted on campus at any time.(p.43)

The Drug Policy states that "the possession and/or use of narcotics or drugs, other than those medically prescribed, properly used, and in the original container, by students or staff on University property or while on University business is prohibited. The distribution and/or sale of narcotics or drugs by students or staff on University property or while on University business is prohibited." In addition, "any and all types of drug

paraphernalia including, but not limited to, bongos, pipes, or any items modified or adapted so that they can be used to consume drugs are not permitted on University property. Drugs and drug paraphernalia will be confiscated when found on University property. A violation of this policy is grounds for separations from the University.”(p.46)

In an effort to guarantee the decorum of the recruiting process, all student hosts must abide by all University and NCAA policies and maintain an honorable image by respecting the following:

- No underage use of alcohol
- No use of drugs
- No use of sex, strippers, or gentlemen’s clubs as a recruiting device
- No activity that violates criminal law
- No gambling/gaming activities

In addition, during the course of the visit, there should be no drinking at all by prospects and student hosts, regardless of age or circumstance.
