Dear Madam/Sir,

It is with regret that I inform you that Mr Peter King has advised the World Heritage Centre of his resignation as Chairperson of the World Heritage Committee. Furthermore, Mr King is unable to attend the 13th General Assembly on 30 to 31 October 2001.

Please find the letter of resignation from Mr King attached upon his request.

In accordance with Rule 14.2 of the Rules of Procedure,

"if the Chairperson ceases to represent a State member of the Committee or is for any reason unable to complete his term of office, he/she is replaced by a Vice-Chairperson, in the English alphabetical order of States members of the Committee, for the remainder of the term of office."

As a result, the State Party of Canada has been asked to designate the name of the new temporary Chairperson of the World Heritage Committee.

Following the elections of the new World Heritage Committee members at the 13th General Assembly, the new Bureau members and Chairperson will be elected by the Committee at its 5th Extraordinary session on 1 November 2001.
