At the recommendation of the Consultative Body of the World Heritage Committee established at its twenty-first session in Naples, Italy, December 1997, we are soliciting your assistance in verifying the accuracy of the following information:

- 1. Brief Descriptions of each World Heritage property in your country (English and French)
- 2. State Party Information Sheets
- 3. Contact address for local institutions, museums and management authorities for each site

Both the Brief Descriptions and State Party Information Sheets are being, or will be, made available to the public via the Internet and in print form on demand. Changes in the Brief Descriptions, once approved by the appropriate advisory body and translated, will be incorporated into the next revised edition of the booklet to be published in the year 2000.

We would also like to improve the distribution of the *World Heritage Newsletter* and other publications available from the World Heritage Centre. In addition, we are frequently called upon to supply local addresses for site management authorities and other local institutions with specific information about the World Heritage properties.
