California is the best-prepared state in the nation to receive and maximize the benefit of a \$4.7 billion share of \$8 billion in federal funding for high-speed train development under the American Recovery and Reinvestment Act (ARRA).

State and Local Match for \$4.7 Billion in Federal High-Speed Rail Funding Will Provide Nearly a \$10 Billion Boost for California's Economy

"California is a leading contender for this federal funding because our true highspeed rail system is further along than any other project in the country. We can double the value of the federal government's dollars by matching them with state bond funds approved by California voters last year. And we can break ground before the federal government's 2012 deadline, providing a huge shot in the arm to the state and national economies with thousands of jobs and billions of dollars of economic activity."

California's High-Speed Rail Authority's application for more than \$4.7 billion in federal stimulus funding for engineering, design and construction on the state's high-speed train system will generate nearly a \$10 billion investment when state matching funds are added in. The funding California has requested would create nearly 130,000 quality jobs throughout the state.

The application includes dozens of projects among every section of the 800-mile system:

\$980 million for San Francisco to San Jose - 34,200 new jobs

- Improvements at San Jose Diridon and San Francisco 4th & King Stations and platform extensions at San Francisco Transbay Terminal
- Grade separations and safety state-of-the-art "positive train control"
- Electrification and other upgrades on shared alignment with Caltrain

\$466 million for Merced to Fresno - 10,500 new jobs

- Grade separations, guideway structures, utility relocation, earthwork and track
- Environmental mitigation and right-of-way acquisition

\$819.5 million for Fresno to Bakersfield - 16,500 new jobs

- Grade separations, guideway structures, utility relocation, earthwork and track
- Environmental mitigation and right-of-way acquisition

\$2.187 billion for Los Angeles to Anaheim - 53,700 new jobs

- **High-speed train facilities** at Los Angeles Union Station, Norwalk Station, and the Anaheim Regional Transportation Intermodal Center
- Grade separations, utility relocation, guideway structures, tunneling, earthwork and track
- Environmental mitigation and right-of-way acquisition

\$276.5 million for preliminary engineering and environmental work – 12,000 new jobs

In all other system segments, including Los Angeles to San Diego via the Inland Empire, Los Angeles to Palmdale and Bakersfield, Sacramento to Merced, San Jose to Merced and the Altamont Rail Corridor.

In August 2009, California applied for an additional \$1.1 billion in a separate ARRA funding category for improvements to existing intercity passenger rail services and near-term job creation. President Obama is expected to announce all high-speed rail stimulus funding awards in December.
