LIST OF SELECTED PROJECTS – The following list of transportation projects recommended for funding by the American Recovery and Reinvestment Act (ARRA) has been approved by the Florida Legislative Budget Commission (LBC).

SELECTING PROJECTS FOR ARRA FUNDING – The Department distributed to its seven (7) geographical Districts a Section 5311 ARRA Grant Application Manual in early 2009. This manual contained general program information and requirements, threshold criteria, a description of the grant award process, general instructions for forms/exhibits and certifications, and grant application information. Each District notified prospective applicants within their geographical area. After evaluating applications the Florida Department of Transportation (FDOT) has been working with cities, counties, Metropolitan Planning Organizations (MPOs) and other transportation partners throughout the state to develop the list of selected projects. This effort is based on the established transportation planning processes.

FEDERAL REQUIREMENTS FOR TRANSPORTATION STIMULUS PROJECTS – All candidate projects must meet federal requirements for federal transportation aid. They must also be completed within the approved timelines. The following are examples of requirements applicable to transportation projects funder under the Act:

- All projects must be included in an approved Statewide Transportation Improvement Plan (STIP).
- Transit projects must be coordinated with the relevant transit operating agency, MPO or FDOT.
- Pursuant to the National Environmental Policy Act (NEPA), all capital structure projects must have completed the required assessments of environmental impacts.

FACTORS FOR PRIORITIZIING PROJECTS - Priority projects are those projects which:

- Have the potential to generate revenue and jobs
- Are geographically balanced
- Are located in economically distressed areas
- Can be completed within 3 years
